**3. Genesis Place**

Residents who qualify for the Participant Support Program are eligible for a 50% discount off registered programs (some restrictions may apply) and are entitled to receive 50% off all types of Genesis Place passes (day, monthly, multi-use and annual). Genesis Place Staff reserve the right to limit the number of discounted registrations per course or program should this become necessary. Also, there is a limit of one type of pass per person at one time. Please register at Genesis place for programs and show your APSP pass card.

**4. Transit**

The Airdrie Participant Support Program provides discounted cash fares and monthly passes onboard Airdrie Transit services. Registered clients must show their Airdrie Participant Support Program (APSP) card upon boarding an Airdrie Transit bus to receive the cash fare discount and the card must remain in the possession of the user at all times while on the system. Registered clients must show their APSP card to purchase a discounted monthly pass for Airdrie Transit services at City Hall. Please note there is a limit of one (1) monthly pass per registered client.
