

Corporate Pass Information/Discount Contract

Let us be a part of wellness in your workplace. Genesis Place wants healthy living to be a part of your lifestyle and that of your employees! Take advantage of our reduced corporate rate and sign up today!

With this plan, Genesis Place agrees to fund the discounted rate of **\$109.35** which is equivalent to 20% of the Annual Adult membership. To enroll, a Corporate Pass Discount Contract must be completed by a designated person within your organization (and updated with Genesis Place accordingly).

Registration is easy! How does the Corporate Discount Program Work?

- Assign the contact person from your business to represent your group and then complete and return the Corporate Pass form. There must be a **minimum of 4 employees** (at all times).
- Once registered and approved your company will receive the corporate discount. Upon approval of the Corporate Pass for the company, there will be a 2 week period where the 4 employees (minimum number required) can sign up for their Annual pass. This date is to be determined between the designated person within your organization and Genesis Place staff.
- In order to qualify for enrollment, the employee must enroll in the program. Family members of employees are not eligible without employee enrollment. Employees will complete a registration form (individual and/or family members) and register with Customer Service staff.
- Corporate passes are to be paid in full at the time of purchase and all companies receiving a corporate pass must provide the following documentation:
 - 1) A current pay stub indicating employee name, date and company name or
 - 2) Letter from HR or administration indicating the information above.
- Please note this plan cannot be combined with any other promotion or membership Plan. Fees are applied on an annual program only; no other monthly plans or multiple use plans will be considered.
- The pass is subject to rules and regulations put forth by Genesis Place, which are listed on the Corporate Pass Application.

Criteria for Corporate Incentive Program

The employees of the company are given a 2 week time frame to sign up for the Corporate Rate/Discount (maximum of **\$109.35**). If the criteria of at least 4 employees have not signed up, Genesis Place has the right to switch the applicable passes back to a regular pass (at the current rate and original start date). We acknowledge that Genesis Place may process this according to the 2 week time frame (date) that was agreed upon, should the requirements not be met and will be payable immediately. Should there be a change of less than 4 employees at any time, Genesis Place has the right to switch the applicable passes back to a regular pass (at the current rate and original start date). Should this occur, Genesis Place will contact and advise the applicable pass holders. Note that it is the responsibility of the organization/business to monitor the corporate employee minimum.

2. This plan/pass is good for a 12 month period from the start date at the bottom of this contract. You will be notified at least one month prior to the expiration of your pass to allow you time to renew.
3. **This authorization may be cancelled at any time upon thirty (30) days written notice in advance. Membership privileges will be suspended one month from receipt of said written notice and a \$50.00 cancellation fee will apply (fee subject to change).**
4. Family Pass Requirements:
 - Option A: 2 Adults living in the same household (require proof of address)
 - Option B: 2 Adults along with immediate children (documentation such as Alberta Health Care or Birth Certificate may be required) under the age of 18 living in the same household (require proof of address).
 - For students attending Post Secondary School, we require documentation/receipt stating full time enrolment status (Student ID cards alone are not accepted as proof). Applicable to ages 18 – 25.
5. (*) The Executive Pass is only available to patrons over the age of 18. There is a nominal fee of \$5/month to rent an overnight box in the room (to be arranged through Customer Service).
6. Ability to put your pass on hold 2 times per year, total amount of extension cannot exceed a 6 month period. Passes will be extended no longer than 6 months past the original expiry date. Holds related to a family pass cannot be processed for one individual on the pass.
