#### **PUBLIC NOTICE TO ELECTORS**

SECTION 251 - THE MUNICIPAL GOVERNMENT ACT

**TAKE NOTICE** that the Council of the City of Airdrie, in the Province of Alberta, has given first reading to borrowing Bylaw No. B-12/2022 which will, upon final passage and approval, authorize the proper officers of the City of Airdrie to borrow monies from the Province of Alberta or another authorized financial institution by way of debenture issue, to pay for the cost of the following municipal purpose, namely for the 2022 40<sup>th</sup> Avenue Corridor Capital Projects.

The net amount to be borrowed on the credit and security of the municipality at large by the issue of the debenture is \$5,448,950. The debentures are to be repayable to the Province of Alberta or another authorized financial institution in thirty (30) equal consecutive semi-annual instalments of combined principal and interest, the annual interest not to exceed ten per centum (10%), or the interest rate as fixed from time to time by the Province of Alberta;

**TAKE NOTICE** that the Council of the City of Airdrie, in the Province of Alberta, has given first reading to borrowing Bylaw No. B-15/2022 which will, upon final passage and approval, authorize the proper officers of the City of Airdrie to borrow monies from the Province of Alberta or another authorized financial institution by way of debenture issue, to pay for the cost of the following municipal purpose, namely for the 2022 40th Avenue – Highview Gate to 800m East (Deep Utilities) Capital Project.

The net amount to be borrowed on the credit and security of the municipality at large by the issue of the debenture is \$7,100,800. The debentures are to be repayable to the Province of Alberta or another authorized financial institution in thirty (30) equal consecutive semi-annual instalments of combined principal and interest, the annual interest not to exceed ten per centum (10%), or the interest rate as fixed from time to time by the Province of Alberta;

**TAKE NOTICE** that the Council of the City of Airdrie, in the Province of Alberta, has given first reading to borrowing Bylaw No. B-11/2022 which will, upon final passage and approval, authorize the proper officers of the City of Airdrie to borrow monies from the Province of Alberta or another authorized financial institution by way of debenture issue, to pay for the cost of the following municipal purpose, namely for the completing the Airdrie Multi-Use Facility and Library Capital Project.

The net amount to be borrowed on the credit and security of the municipality at large by the issue of the debenture is \$25,000,000. The debentures are to be repayable to the Province of Alberta or another authorized financial institution in fifty (50) equal consecutive semi-annual instalments of combined principal and interest, the annual interest not to exceed ten per centum (10%), or the interest rate as fixed from time to time by the Province of Alberta;

**NOW THEREFORE NOTICE** is hereby given by the Council of the City of Airdrie that, unless a petition of the electors for a vote on Bylaw No. B-12/2022, Bylaw No. B-11/2022, or Bylaw No. B-15/2022 or is demanded, as provided for by the terms of Section 231 of the Municipal Government Act, the said Council may pass the said borrowing bylaw.

All persons interested are hereby notified and they are required to govern themselves accordingly.

**INFORMATION FOR ELECTORS** I Pursuant to Section 1(i) of the Municipal Government Act an "elector" means: a person who is eligible to vote in the election for a councillor under the Local Authorities Election Act.

Pursuant to Section 47(1) of the Local Authorities Election Act a person is eligible to vote in an election if he is at least 18 years old, is a Canadian citizen, and has resided in Alberta for the 6 consecutive months immediately preceding election day and is resident in the area on election day.

A poll may be demanded in the City of Airdrie by electors of the municipality equal in number to at least 10% of the population in accordance with the provisions of Section 223 of the Municipal Government Act and in accordance with the provisions of Section 251 of the Municipal Government Act.

The petition for a vote must be received by the chief administrative officer within 15 days of the last publication of this notice and shall contain on each page "an accurate and identical statement of the purpose of the petition". (Further requirements of the petition are provided in Section 224 of the Municipal Government Act.)

**DATE** of the last publication of this notice is the 14th day of April 2022.
